# WHAT DOES FUTURE HOME INVESTMENT ACCOUNTS D/B/A STAIRS FINANCIAL DO WITH YOUR PERSONAL INFORMATION?

## Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

### What?

The types of personal information we collect and share depend on the product or service youhave with us. This information can include:

- Contact information (name, email address, phone number)
- Prospective purchase property location and estimated price
- Personal financial data (savings, Income, debt payments)
- Credit score
- Household size
- Profession
- First time home buyer status and veteran status

### How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Stairs Financial chooses to share; and whether you can limit this sharing.
